Persons / businessmen, who have not duly registered under the Business Names Ordinance or the Companies Act, won't be considered for the registration.

Item No: 05 Personnel protective equipment and sanitary ware

Face shield, Face mask, uniform materials, gloves, shoes, soap and cleaning materials, sanitizer

Item No: 06 Packing equipment

Plastic boxes, packing materials, regiform boxes, corrugated boxes, shopping bags, fertilizer bags, printed polythene packing

Item No: 07 Office equipment

Computer Accessories & all kind spare parts, Office equipment, Steel & Wooden furniture, Printers, Photocopy machine, typewriter, Roneo Machines, Scanner, Projector, Fax machine, CCTV Camera, timekeeper machines, binding machines, calculators, telephone & accessories

Item No: 08 Stationery

Computer software, computer toners, all office stationery, ribbon, fax rolls

Item No: 09 Showroom accessories

Deep Freezer, Display cabinets, Electronic scales (15kg / 30kg / 150kg) Cash Register machines, Digital name displaying board, Barcode machines, Fish cutting machines and blades, refrigerators

Item No: 10 Computer System and Information Technology

ERP System, Barcode system

Maintenance of vehicle services, Garages for repairing, tinkering and painting

Pre-qualifications

- I. Submission of a dealers' list for necessary action.
- II. Address, telephone numbers, e-mail address and the business registration
- III. Suppliers' statues (importer, an individual business, manufacturer, wholesaler and others)
- IV. Must be registered with ICTAD for work in the construction industry.

Conditions

- Separate applications should be submitted for each item. Applications for registration may be obtained from Supply Division of Ceylon Fisheries Corporation, from 01st of November 2023 to 30th of November 2023 from 9.00a.m. to 3.00p.m. by paying Rs. 3,000/- (nonrefundable) for each Item. A written request on a letterhead of the Institution should be submitted to obtain the applications.
- 2. Ceylon Fisheries Corporation reserves the right to accept or reject any application and has right to obtain bids even from the unregistered suppliers. In case any registered supplier fails to submit the bids or to supply the goods and services, the Corporation has right to remove the name of said registered suppliers from the list of registration without any notice.
- Duly filled applications should be sent by Registered Post to Chairman, Ceylon Fisheries Corporation, Rock House Lane, Colombo 15 on or before 05TH of December 2023. The top-left hand corner of the envelope containing the application should be marked as "Registration of Suppliers for 2024, No..."
- 4. The selection procedure registration is subject to the decision of the management of the Ceylon Fisheries Corporation.
